Executive Director Gary Ingle led a review of the financial reports. The February 28, 2012 financial reports were the most recent reports available. Assets of MTNA are \$3,487,431.79 with liabilities of \$65,100.28, and income of \$2,241,430.76 with expenses of \$1,121,071.93.

Unrestricted long-term investments are \$743,183.14. The Foundation Fund Endowment Account has assets of \$806,308.52 and the McHose Trust has assets of \$586,044.70

He updated the Board on the status of the request by the Ohio Attorney General's office for documents and reports from MTNA and the MTNA response. The request was generated as a result of two "anonymous" complaints filed online. He, the MTNA staff, and the MTNA attorney have provided all of the materials requested by the Attorney General. No decision has been communicated by the time of the Board meeting.
